

NOTICE OF PUBLIC HEARING BEFORE THE CITY COUNCIL FOR THE CITY OF LACY LAKEVIEW,
TEXAS:

THERE HAVE BEEN THREE (3) REQUESTS THAT THE CITY OF LACY LAKEVIEW ANNEX CERTAIN TRACTS OF LAND THAT LIE WITHIN THE EXTRA-TERRITORIAL JURISDICTION OF LACY LAKEVIEW. THE TRACTS OF LAND ARE GENERALLY IDENTIFIED AS: 1) THE WORLD HUNGER RELIEF, INC. PROPERTY LOCATED AT 356 SPRING LAKE ROAD, 2) 303 N. VIRGINIA STREET (APPROXIMATELY 1.773 ACRES), AND 3) TIKA CHEEMA PROPERTY OUT OF THE SAMUEL BURTON SURVEY, BEING APPROXIMATELY 59.2 ACRES, MORE OR LESS OF A CALLED 114.835 ACRE TRACT EAST OF INTERSTATE 35. THE PROPOSED ZONING FOR THESE TRACTS WILL BE AS FOLLOWS: 1) AND 3) - AGRICULTURAL AND 2) RESIDENTIAL. A MAP AND DETAILED DESCRIPTIONS OF THE PROPERTIES CAN BE VIEWED AT THE CITY SECRETARY'S OFFICE AT CITY HALL DURING NORMAL BUSINESS HOURS. TWO PUBLIC HEARINGS WILL BE HELD TO RECEIVE INPUT ON THESE REQUESTED ANNEXATIONS PRIOR TO CONSIDERATION BY THE CITY COUNCIL.

CRAVEN, LACY LAKEVIEW, ON **TUESDAY, JUNE 19, 2007 at 6:00 p. m.** A SECOND PUBLIC HEARING WILL BE HELD ON **TUESDAY JUNE 26, 2007 at 6:00 p. m.** AT THE SAME LOCATION. THE CITY COUNCIL INTENDS TO CONSIDER INSTITUTING ANNEXATION PROCEEDINGS ON THESE THREE (3) REQUESTS AT THE REGULAR CITY COUNCIL MEETING TO BE HELD ON **TUESDAY, JULY 24, 2007 at 6:00 p. m.** THE CITY COUNCIL MAY APPROVE OR DISAPPROVE THE REQUESTED ANNEXATIONS AS SUBMITTED.
