The voter-approval rate is the highest tax rate that City of Lacy Lakeview may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that City of Lacy Lakeview is not proposing to increase property taxes for the 2022 tax year.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, City of Lacy Lakeview is not required to hold an election to seek voter approval of the rate.
